Guidance for sending your potato sample for post-harvest virus diagnosis to Fera Plant Clinic

- **Standard Growing-on Testing** prices will change during the year based on 'Peak' and 'Off Peak' seasons:
Peak testing = 1st September – 28th/29th February, **Off-peak testing** = 1st March – 31st August.

How to select your sample

- Samples sent for **Rapid Direct Tuber Testing** or **Standard Growing-on Testing** need 120 tubers selecting, if you do not provide this amount the results of the testing are not as statistically accurate.
- For the **Spraying test - 6 symptomatic tubers**, please send a sample that is representative of the problem - we need to see the full range of symptoms. Try to include the boundary between healthy and diseased tissue where possible.

How to package your sample

All samples should be packed securely in either a potato sack or a strong cardboard box with screwed up paper to secure samples. Please ensure that this Sample Submission Form is included in the package inside a separate bag.

Ideally, samples should be dispatched by either courier service or first-class post to arrive at Fera next day. If possible, avoid sending samples over the weekend/Bank holidays, however if unavoidable mark the outer packaging for fresh plant material with 'Please refrigerate on arrival' if necessary.
